merical Division Veterans Association (ADVA)2013 National Reunion: The ADVA national reunion committee has blocked the following dates as the 2013 National Reunion to be held in Nashville, TN. Check-in will be on Wednesday September 11, 2013. Thursday Sept 12 will be field trip to Fort Campbell and the 101st Airmobile Division. Friday Sept. 13 a trip is being scheduled for visiting the Tennessee Vietnam Veterans Memorial, (one of the nicest in the country) followed by a trip to the Country Music Hall of Fame, Dinner and the Grand Ole Opry. Saturday Sept 14 will be meetings social time and the annual banquet. Sunday will be check out. More will be published as we get more information from the National Committee. Please plan to attend as we are also scheduling our Chapter Annual Meeting at the same period.

**OLA Passes Senate:** Returning to work this week, the Senate quickly passed a cost-of-living adjustment or COLA for VA. The 1.7 percent increase affects VA compensation for disabled veterans and surviving spouses. The COLA bill ties the rate for veterans' COLA to the increase in Social Security compensation which is determined each year by the consumer price index (CPI). The House passed their version in July. The President is expected to sign the bill soon. The increase in benefits for 3.9 million veterans and their families will take effect December 1, 2012. Since benefits are paid retroactively, the first check to reflect the increase is due on or about January 1, 2013.

**New Oil Power:** The main topic of conversation at a recent OPEC conference in Vienna was the reemergence of the United States as a global oil power. As Financial Times reports, "over the past three years, the United States has accounted for the entire net increase in global oil output, excluding OPEC members and former Soviet republics." In fact, the United States increased oil and liquid hydrocarbon output by 1.1 million barrels per day between 2008 and 2011. As the United States expands development of shale oil, output will only grow. Ryan Lance, CEO of ConocoPhillips, says his firm expects U.S. shale-liquids production to grow by 150 percent by 2020. "Thanks to both shale and Canadian oil sands, North America could become self-sufficient in oil... by 2025 and even a net exporter."

ouse Committee Discusses Employment Initiatives: The House Veterans Affairs Subcommittee on Economic Opportunity held a hearing to discuss ongoing veterans' employment initiatives. The committee members asked representatives from VA and the Department of Labor to evaluate their programs. Most of the hearing focused on persistent high unemployment among Iraq and Afghanistan-era veterans, the VA's implementation of the new Veterans Retraining Assistance Program (VRAP) and the Department of Labor's goal to refine the roles of Disabled Veteran Outreach Program specialists and Local Veterans Employment Representatives. VFW will continue to monitor and advocate for comprehensive veterans' employment solutions and hold agencies accountable for the programs they have implemented to serve our nation's heroes Change the 20-year military retirement plan to resemble civilian plans.

A Increases Vets Retraining Assistance Program: VA announced they have filled 36,000 of the 45,000 job training openings available under the Veterans Retraining Assistance Program (VRAP) passed as a part of the *VOW to Heroes Act*. An additional 55,000 openings will be available October 1, 2012. VRAP provides up to \$1,473 a month in GI Bill benefits for those taking full-time courses to learn the skills necessary to land a job. VFW was instrumental in getting the provision passed as a part of the comprehensive jobs bill and encourages eligible veterans to apply online. **T**<u>ricare Prime Announces Fees for 2013</u>: The 2012 TRICARE Prime enrollment fees for uniformed services retirees and their families went into effect in October 2012. The new fees for 2013 are \$269.28 for Retirees and \$538.56 for Retirees and their family members. Survivors of deceased active duty sponsors and medically retired service members and their dependents are exempt are exempt from annual fee increases. Their enrollment fees are frozen at the rate in effect when they were classified and enrolled in TRICARE Prime. Their fees remain frozen as long as there is no break in their TRICARE Prime enrollment. For more information please visit http://tricare.mil

This week of events is made possible by thousands of volunteers who organize local ceremonies, raise funds to sponsor wreaths, and participate in the events. We receive no government funding. #### <u>A Offers a New Tool to Help Veterans Prevent</u>

**Diabetes:** The Department of Veterans Affairs today announced the implementation of a pilot version of the Diabetes Prevention Program (DPP), a program being promoted nationally by the Centers for Disease Control and Prevention, aimed at reducing the number of Veterans who develop diabetes. "The Diabetes Prevention Program will provide Veterans with another tool to help them lead healthier, fuller lives, reducing their risk for diabetes," said Secretary of Veterans Affairs Eric K. Shinseki. The DPP was a major multi-center clinical research study aimed at discovering whether modest weight loss through dietary change and increased physical activity or treatment with the oral diabetes drug metformin could prevent or delay the onset of Type 2 diabetes. The study enrolled participants who were prediabetic— overweight and with blood glucose (blood sugar) levels higher than normal, but not high enough for a diagnosis of diabetes. Results showed those who lost a modest amount of weight through dietary changes and increased physical activity sharply reduced their chances of developing diabetes. "Approximately 24 percent of Veterans have Type 2 diabetes," said Dr. Linda Kinsinger, VA's chief consultant for preventive medicine. "We've monitored the DPP's results and we feel that it could be another tool to make a difference for Veterans." Through VA's pilot DPP, which will be offered on a strictly voluntary basis, some Veterans who are at risk for, but not diagnosed with, diabetes will attend a series of group sessions and will be given predetermined weight loss and physical activity goals. Research has shown that, while many Veterans benefit by establishing their own health goals, others show positive improvement working towards goals determined by the program. Other Veterans at risk for diabetes will receive weight management care through MOVE! - VA's current weight management program. The program targets a broad range of patients who are obese or overweight with obesity-related conditions, whereas the DPP specifically targets those obese individuals who have laboratory evidence of prediabetes. Because VA is eager to try new approaches to promoting health and preventing disease, it is implementing a pilot VA version of the DPP. A limited number of Veterans with prediabetes will be able to participate in this pilot clinical program at the medical centers in Minneapolis, Baltimore, and GA coordinating center. Lettin' the cat outta the bag is a whole lot easier'n puttin' it back. Will Rogers **R**<u>egistering your DD 214 with the County Clerk</u> of Courts/ VA Rep: One of the first things you are told before you are discharged from the Military is, "Make sure you register your DD214." It may seem like this is really not that important, until you find yourself searching for this document. You may need it to verify VA benefits or for a job interview and without it, you have no documented proof that you actually completed a military enlistment. Let's face it, anyone can say they were in the military and without your DD214 you are just like everyone else. Where to Register Your DD214: The first place you may want to register your DD214 is with your County Veterans Office because, it will be beneficial in the future, when you are ready to take advantage of the VA benefits that you are eligible for. Some of the benefits you may have rights to are:

Education Benefits

VA Home Loans VA Medical Benefits

Disability Claims

Employment Opportunities

These are just a few of the benefits that qualifying veterans are eligible to receive. By having your DD214 on file with the County Veterans Office, the office can assist you with filing VA applications and required forms that may be needed to apply for VA benefits. In addition, by registering with the county veteran's office, you can ask to receive county veterans' information about job fairs, emergency financial assistance, and many other county veteran programs. The 2<sup>nd</sup> place your going to want to register your DD214 is the Clerk of Courts at your County Courthouse. This is for one reason and one reason only; if your original copy gets lost while moving, cleaning the house, or is just accidentally thrown away. You have a back-up... just a car ride away.

A Guarantees 20 Millionth Home Loan: The Department of Veterans Affairs announced it has guaranteed 20 million home loans since the home loan program was established in 1944 for returning World War II Veterans. The 20 millionth loan was guaranteed for a home in Woodbridge, Va., purchased by the surviving spouse of an Iraq War Veteran who passed away in 2010. Given the current low interest rates, the program has grown significantly in the past five years, with 71 percent more purchases and 20 times as many refinances processed in fiscal year (FY) 2012 than in FY 2007. Currently, there are 1.7 million VA guaranteed home loans in existence with a total value of \$284 billion. VA has guaranteed 540,000 mortgages in 2012. "The 20 millionth VA home loan is a major milestone and is a testament to VA's commitment to support and enhance the lives of Veterans, Servicemembers, their families and survivors," said Allison A. Hickey, VA's undersecretary for benefits. "As a result of their service and sacrifice, as a group, they prove to be disciplined, reliable, and honorable-traits that are ideal for this kind of national investment." The program makes home ownership more affordable for eligible Veterans, Servicemembers, and surviving spouses by providing access to lower cost financing. VA loans are also attractive within the mortgage industry because they protect lenders from loss if the borrower fails to repay the loan. Mortgages guaranteed by VA have had the lowest foreclosure rate for the last 17 quarters and the lowest delinquency rate for the last 14 quarters compared to all other types of home loans. Much of the strength of VA's home loan program stems from the efforts of VA to ensure Veterans receive every possible opportunity to remain in their homes and avoid foreclosure. Since 2009, VA's efforts have resulted in over \$8 billion in savings to taxpayers in foreclosure avoidance.

DU Honors Special Operations Community: During a dinner gala in November 2012, the National Defense University Foundation honored members of U.S. Special Operations Command for their service and sacrifice in the war against terrorism. The American Patriot Award recognizes exceptional Americans who have demonstrated a profound and abiding love of country. The award also honors those who have provided inspirational leadership and selfless dedication to national security and world peace, significantly advancing national ideals, values and democratic principles. Navy Adm. William H. McRaven, commander of SOCOM, accepted the 2012 award on behalf of the men and women he leads, as his unit celebrates its 25th birthday. The command was established by an act of U.S. Congress in 1987. "What an honor it is to be here this evening representing the men and women of the special operations force," he said, before introducing each service's top officer and enlisted leader. "These men represent the 66,000 soldiers, sailors, airmen and Marines that make up the U.S. Special Operations Command," McRaven said. The admiral also acknowledged former SOCOM commander, Army Gen. Bryan "Doug" Brown, as well as five recipients of the Distinguished Service Cross, five Navy Cross recipients and one Air Force Cross recipient as "modern-day SOF heroes." "In addition to these men, since 9/11, SOF warriors have been the recipients of another 10 service crosses and four Medals of Honor, including Ranger [Army] Sgt. 1st Class Leroy Petri and three posthumous awards, to Green Beret [Army] Staff Sgt. Rob Miller and [Navy] SEALs Mike Murphy and Mike Monsoon," Craven said. The SOCOM commander noted the years since 9/11 have highlighted the "unique nature" of special operations, citing events ranging from the capture of Saddam Hussein to current efforts of troops assisting Afghan Local Police. "From the jungles of the Philippines and Colombia, to the mountains of Yemen, to the deserts of North Africa, to waters off Somalia," Craven said, "our special operations forces have been instrumental in protecting American lives abroad and keeping violence from our shores." "These operations have captured the imagination of the American public and the

attention of the world," he said. A theme throughout Craven's

remarks was a question he said he's often asked: "What makes special operations so special?" "Well I can tell you that, as good

as they are, the men and women of special operations are no

more courageous, no more patriotic, no smarter or no more com-

mitted than any other man or woman in uniform," he said. "All

of us who have served have been inspired by the uncommon

valor of Medal of Honor recipients Sal Gaunt, of the U.S. Army,

and Marine Staff Sgt. Dakota Meyer," Craven said. "We are all

moved by the young men and women of all the services who re-

enlist at a time when the fighting is the toughest and their sacri-

fice the greatest." The admiral also credited young service mem-

bers who are "wickedly smart" for their skills and technical abili-

ties. "We are the sum of the parts of the greatest military the

world has ever seen," Craven said. "As SOF warriors, we are

shaped by our services, forged in the crucibles of training posts

like Parris Island, the Great Lakes, Lockland Air Force Base and

Fort Benning." "It is from the services that we gain our heritage,

our tradition, our creeds," he said. "It is from the long lineage of

soldiers, sailors, airmen and Marines that came before us that

drive our sense of duty." Craven said special operations forces

are a "microcosm of America," drawing strength from every cor-

ner of the United States and the world. "Not only do we benefit from the strength of our parent services, but we are blessed to be part of a larger interagency organization," he said, citing the State Department, Central Intelligence Agency and others. "We have achieved a unity of purpose -- an action that is unparalleled in the history of warfare," McRaven said. "So what is it that makes special operations so special?" McRaven asked again. "It is men and women who are steeped in the heritage of their service, bonded by a common purpose, inspired by the nation and who are willing to fight and die for the American people that they love so much."

**T**<u>wo Korean War MIAs Identified:</u> The Defense POW/Missing Personnel Office recently announced the identifications of remains belonging to two Korean War soldiers. Returned home are:

\* Army Sgt. Stanley W. Bear, 19, of Greenup, Ky. On Sept. 4, 1950, Bear would be reported as missing after battling enemy forces near Haman, South Korea. He was assigned to F Company, 2nd Battalion, 27th Infantry Regiment, 25th Infantry Division. Unidentifiable remains would eventually be recovered and interred as an "unknown" in the National Memorial Cemetery of the Pacific in Honolulu.

\* Army Cpl. Elmer C. Kidd, 22, of Seneca Falls, N.Y. In late November 1950, Kidd and his unit, the 31st Regimental Combat Team, were advancing along the eastern banks of the Chosin Reservoir, in North Korea, when they were attacked by a massive enemy force. Kidd would be reported missing after a fighting withdrawal to positions south of the reservoir.

ear Editor: I just read your newsletter for November, especially the article about Kham Duc. I was there on May 12, 1968. As a matter of fact, on this date November 4th, 1967 is my 45th anniversary of leaving for Nam. The aircraft that was shot down was intended for my company C 2/1. We were the last infantry company out of Kham Duc. The 3 Air Force personnel were not the last ones out. Three guys from one OP were there for 6 days. One guy was named Ron Sassenberger from Idaho. I met him at a reunion of the 196th in Hampton, Virginia in 1992. He told the story to some of us of their survival until their rescue 6 days later. The NVA were searching for him and two other guys the whole time. The CH-47 crashed near me and with the help of some other guys we were able to get the crew out because it was starting to burn. It failed to auto rotate down. The Huey that went down happened almost in the middle of Charlie company. It flipped on it's side almost on top of the CP. One gunner was trapped underneath and we were able to raise the chopper off of him and get him out. When we left, the NVA had control of most of the camp by then. Pretty harrowing day!!!! I saw the C-130 that was nearly hit by the mortar round. It blew out one of the tires and the crew was trying to stop the aircraft. It was carrying A 1/46th, I believe. I remember vividly those guys jumping out of the cargo door in the back of the aircraft. We ran out and helped some of them off the runway. Later, we watched that same aircraft take off empty. Just reflecting a little of that day. The article just brought it to mind. Maybe some of Bravo's guys from that era may have been there too. I could tell you much more but I won't bore you any longer.

## **Assisted Living House and VA Benefits**



If a home in an assisted living community is what you need, then it's possible that veterans' benefits can help. Homes in assisted living communities are often for sale rather than rent. VA borrowers with assisted living needs may be able to get a VA-guaranteed mortgage to finance a property located in an <u>assisted living</u> community.

As long as the property meets VA requirements for acceptable use, then it can be considered for VA financing. For instance, condos and townhomes must be on the VA-approved list, and all properties must undergo a VA appraisal and provide safe living conditions.

Qualified veterans or surviving spouses with assisted living needs may purchase approved homes in assisted living communities using the VA Home Loan Guaranty Program, and there may be additional VA benefits available.

Through an underutilized VA benefit called Aid and Attendance, wartime veterans and surviving spouses can receive reimbursement for in-home care. Those who are unable to feed and dress themselves and take care of bathing and other bodily needs without assistance, and those who are bedridden or need help with prosthetic or orthopedic devices, may qualify for the Aid and Attendance benefit. Also, those with physical or mental injuries or illnesses that may require assistance to protect them from daily environmental hazards or dangers may also qualify.

The annual income threshold for Aid and Attendance is currently \$18,234 for a veteran with no dependents. Those with one dependent can make \$21,615 and still qualify. For each additional dependent, the threshold is upped by \$1,866. For surviving spouses with no dependents, the annual Aid and Attendance threshold is \$11,715. For spouses with one dependent, the threshold is \$13,976 and increases by \$1,866 for each additional dependent.

The advantages of buying a home using a <u>VA loan</u> include:

- No money down up to conforming loan limits
- No monthly private mortgage insurance premiums
- No prepayment penalties
- Competitive interest rates
